Future entry to the Competition by the Club shall not be accepted until the penalty is paid in full.

Competition Rules: A full set of rules is available in the Tournament Conditions Book circulated to Clubs or can be viewed on-line at www.gui.ie/ulster.

Mode of Play: Each team to consist of 5 male members and play shall be 18 holes singles scratch medal play with the best four cards from five to count. Sixteen teams will qualify for the match play stage – four teams from each section. The qualifying Clubs will return to their original venues for the 1st round Matchplay as above, using the following format 1 v 4, 2 v 3 and the winners will play the 2nd round Matchplay on the same day.

Ulster Final: The Semi-Finals and Final to determine the Ulster Section Winner will be played at **Portstewart on 19 August 2012.**

National Final: The National Final to determine the winner of the Irish Senior Cup will be played at **Kinsale Golf Club on 19-22 September 2012.**

Practice: Teams to contact host Club beforehand. Green fees are payable. One practice round (at least) as if playing with a member. Team members to produce identification if requested.
